The Principal, Siddhartha Medical College, Vijayawada in his inspection report has informed that he has visited Nimra Institute of Medical Sciences (NIMS), Teaching Hospital & Research Centre, Nimra Nagar, Jupudi, Ibrahimpatnam, Vijayawada, Krishna District on 08.09.2016 and verified all the documents related to Nimra Educational Society/Nimra Institute of Medical Sciences personally and he has submitted a detailed inspection report with necessary documents for grant of Minority Status to Nimra Institute of Medical Sciences (NIMS), Teaching Hospital & Research Centre, Nimra Nagar, Jupudi, Ibrahimpatnam, Vijayawada, Krishna District for the academic years 2016-17 to 2018-19.

Government after careful examination of the matter and in terms of the guidelines issued in the G.Os. 1st to 4th cited hereby accord Muslim Minority Status Certificate (Fresh) to Nimra Institute of Medical Sciences (NIMS), Teaching Hospital & Research Centre, Nimra Nagar, Jupudi, Ibrahimpatnam, Vijayawada, Krishna District for the academic years 2016-17 to 2018-19.

The Secretary & Correspondent of Nimra Institute of Medical Sciences (NIMS), Teaching Hospital & Research Centre, Nimra Nagar, Jupudi, Ibrahimpatnam, Vijayawada, Krishna District is informed that the Minority Status Certificate accorded to their Institution is non-transferrable. He is further informed that the institution may be inspected at any time by the Minorities Welfare Department and the Higher Education Department and he is directed to make available all the connected records and other relevant documents to the inspecting authorities. The final list of admitted students along with all relevant supporting information shall be sent to the Minorities Welfare Department and the Higher Education Department within 15 days from the cut off date.

6. The Minority institutions should comply with the following conditions in addition to the conditions laid down in G.O. Ms. No. 1, Minorities Welfare (M&R) Department, dated 16.1.2004 :-

- a) The College should inform the community and criteria for eligibility.
- b) The College should submit all the documents concerned with the selection of the candidates.
- c) The College should specify the manner in which the seats are distributed i.e., Convenor quota, Management quota etc.
- d) The Collage should inform the fee structure specified under each category to the Minority Status issuing authority.
- e) The process of inviting application for admission and selection should be online invariably.
- f) One representative from Minorities Department should be nominated as Member of the selection committee not below the rank of Deputy Collector/Deputy Secretary.

The Secretary & Correspondent of Nimra Institute of Medical Sciences (NIMS), Teaching Hospital & Research Centre, Nimra Nagar, Jupudi, Ibrahimpatnam, Vijayawada, Krishna District is further informed that if any violation of the existing Government Orders and the conditions stipulated from time to time is noticed by the Government, the matter will be viewed seriously and the competent authority shall take action as per the existing rules without notice and assigning any reasons thereof.
