Online Applications are invited from qualified candidates in NEET PG-2024 for admissions into Management seats in PG (Medical) Courses in Un-Aided Non-Minority and Minority Private Medical Colleges in the State of Andhra Pradesh for the academic year 2024-25. Candidates from other States and Union Territories must check their eligibility by reading Prospectus.

The candidates should secure the following cutoff percentile in National Eligibility cum Entrance Test (NEET) PG-2024 for Post Graduate Medical Degree/Diploma courses:

General/EWS	50 th percentile
General-PwBD	45 th percentile
SC/ST/OBC (Including PwBD of SC/ST/OBC)	40 th percentile

1. For other eligibility conditions, registration fee, counselling rules and procedure to submit the online application **please download and read the Prospectus and User Manual** displayed on the University website.

2. As per G.O.Ms.No.70, HM&FW (C1) Dept., Dt: 03-05-2017 as amended in G.O.Ms.No.75, HM&FW (C1) Dept., dated 06-05-2017, G.O.Ms.No.57, HM&FW (C1) Dept., dated 28-04-2023, G.O.Ms.No.74, HM&FW (C1) Dept., dated 06-06-2023 and G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023:

- 50% of Seats in each specialty in each college are Management Quota Seats.
- The Seats are categorized into
 1. Management Quota Category – B (S1)– 25%,
 2. Category – C (NRI- S2) – 15%
 3. Category –C (Institutional Preference – S3) – 10%.

3. As per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023 in Non-minority Medical Colleges:

- i. 15% of Subcategory-1 (S1A) seats only are open to the candidates from all over the Country.
- ii. For the Remaining 85% of Subcategory-1 (S1B) seats only Local Candidates of Andhra Pradesh i.e., AU/SVU are only eligible.

4. Local Area:

- i. The entire state of Andhra Pradesh shall be treated as two local areas for the purpose of admissions into Post Graduate Courses in Medical Colleges” i.e., Andhra University and Sri Venkateswara University (including SVIMS) areas for filling up the 85% of Sub category-1 (S-1) seats in private un-aided Non-minority Medical Colleges in the State of Andhra Pradesh.
- ii. **For the candidates who have completed** MBBS from Govt. Siddhartha Medical College, Vijayawada the Local area of the candidate shall be decided by considering the maximum study period of 4 years out of 7 years of study from 6th class to Intermediate/10+2 in the State of Andhra Pradesh.
- iii. For Category–C–NRI(S2): Shall be filled with NRI / NRI Sponsored candidates on the basis of Merit among the applicants qualified in NEET PG-2024.
- iv. For Category–C–Institutional Quota(S3): Shall be filled with the candidates qualified in NEET-PG -2024 sponsored by the Managements of the Private Colleges having Post Graduate Courses in the State of Andhra Pradesh.

5. As per G.O.Ms.No.74, HM&FW (C1) Dept., dated 06-06-2023 in Minority Medical Colleges:

- i. Management Quota-Subcategory-1(S1): 25% of the sanctioned intake of seats, course wise, in each institution shall be filled by the candidates in General Merit based on the NEET PG-2024 ranking.
- ii. Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET PG-2024.
- iii. Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each institution shall be Institutional preference/In-service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET PG-2024.

6. Lower percentage/percentile of marks for SC/ST/BC/OBC /PwBD is only for eligibility purpose and will not be applicable for reservations as there are no reservation quota for these categories as per G.O.Ms.No.70, HM&FW (C1) Dept., dated 03-05-2017.

7. University Fee:

All the selected candidates shall pay the Non – Refundable University Fee of **Rs.49,600/-**

- 8. TUITION FEE: The following is the Tuition fee structure for the academic year 2024-25 to be payable for the Competent Authority Quota seats in Private Un-aided Medical Colleges as per G.O.Rt.No.504, HM & FW (C1) Department, dated 06-08-2024 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.**
